Rules

1. The contestant must be a resident of Warren County. **Proof of residency may be required.**
2. A parent or guardian must accompany each contestant. Only 1 person will be allowed on the stage with each contestant. **NO props allowed.**
3. On the date of the baby show, contestants must be at least 6 months old and no older than 59 months old.
4. Judging will be based on appearance (35%), behavior (35%), cuteness and personality (30%). **The judges' decision will be final.** First, second, and third place winners will be presented a ribbon or trophy in the following age groups:
 - a. Girls 6-12 months - Boys 6-12 months - Multiple(s) 6-12 months
 - b. Girls 13-18 months - Boys 13-18 months - Multiple(s) 13-18 months
 - c. Girls 19-24 months - Boys 19-24 months - Multiple(s) 19-24 months
 - d. Girls 25-30 months - Boys 25-30 months - Multiple(s) 25-30 months
 - e. Girls 31-36 months - Boys 31-36 months - Multiple(s) 31-36 months
 - f. Girls 37-42 months - Boys 37-42 months - Multiple(s) 37-42 months
 - g. Girls 43-48 months - Boys 43-48 months - Multiple(s) 43-48 months
 - h. Girls 49-59 months - Boys 49-59 months - Multiple(s) 49-59 months
5. **\$25.00 entry fee** per contestant **plus \$5** optional newspaper fee, payable to the Warren County A&L Fair, to be paid with registration of entry form. No refunds for contestants who become ill or drop out of the contest.
 - a. Optional newspaper picture, published in the Southern Standard, due at registration. Photographs submitted must have the child's name, age (in months), and parents name must be on the back of the picture.
