No limit on number of contestants.

1. Contestants must reside in Warren Co. for the last six months and attend school in Warren County.
2. Contestants must be 13 years old but not older than 15 on the day of the pageant.
3. Dresses must be formal and below the knee.
4. Contestants will attend all rehearsals or forfeit the right to participate in the pageant.
5. Optional newspaper picture published in the Southern Standard for an additional \$5.00 due at registration.
Shelby Durham Photography will take program pictures at practice for \$10.00. You will be given the digital photos.
6. A child cannot be in both the entertainment and the pageant.
7. Committee members children will not be allowed to enter the pageant.
8. Parents, guardians, etc. will not be allowed in the backstage area.
9. Contestants cannot give up a crown and compete for a crown in the same year.
10. Contestants cannot win the same crown twice.
